Housing to replace Wellsmere Monuments

Old time Jamaica Plain businesses are morphing into housing in Forest Hills, and like the Fireside Tavern and Alco Auto Parts, Wellsmere Monuments, at 3841 Washington St. just outside the square is joining the trend.

Capitalizing on a pun, UHub broke the Wellsmere story on Sept. 29. “Monumental residential building propped for Washington Street near Forest Hills.”

If built, it will be the biggest residential building at that end of Forest Hills, with five-to-seven stories around a street-front courtyard with 165 units and almost 6,000 square feet of commercial space. There will be 33 at-grade parking spaces.

The property is owned by Joseph Vozzella, who submitted a letter of intent (LOI) to the Boston Planning Department on Sept. 25.

“The project site currently functions more as an historic relic

Opposition intensifies over Redlands shelter

Fierce opposition to the proposed family shelter at 5 Redlands Rd. was expressed during the West Roxbury Civic and Improvement Association (WRCIA) first fall meeting held on Tuesday, Oct. 14.

The shelter was the sole topic of the meeting, which lasted an hour-and-a-half and attracted a standing-room-only crowd of more than 60 people.

Martin Keogh, vice-president of WRCIA, invited Colby O’Brien, vice president of programs for Make Opportunity Count (MOC), the non-profit that will be running the shelter and Tyler Newhall, Director of Legislative Affairs, Division of

A funny thing happened on the way from the theatre... City candidates show their stuff

As this city election season winds and grinds its way to its Nov. 4 conclusion, an unusual campaign event was held this past Saturday night at Hyde Park’s Riverside Theatre Works.

“Spotlight on the Candidates” gave the opportunity to everyone still on the ballot to express themselves – through the performing art of their choice – to an audience of about 150 people.

Of the 25 who survived September’s preliminary election and chose to press on, 11 of them accepted the invitation to take a turn onstage in what was an emceed, revue-style show.

The event was a departure from the candidates’ typical campaign stops. For most, it also took them out of their environment. This could be discerned on the faces of some of those who had ventured out of the green room into the small, crowded lobby as curtain time drew near and a steady stream of theatre goers trudged up the long flight of stairs from Fairmount Avenue.

“I’ve been dreading this night the most,” city councilor at-large candidate

Marvin Dee Mathelier jovially but slightly skittishly announced halfway through the first set and right before throwing himself into a seat-of-his-pants karaoke rendition of Aerosmith’s “I Don’t Want To Miss A Thing” that had the audience singing along with him at full volume.

His statement and performance were indicative: the candidates – many whose nerves were palpable – stepped up and gave their best, with the full support of an appreciative audience.

About half of the candidates/performers chose to sing, with the rest split evenly between dance and spoken word combined with music/dance/other as their way of connecting with the room.

The songs were sometimes of personal significance. City councilor at-large candidate Frank Baker sang The Beatles’ “In My Life” (with his brother Tom accompanying on guitar) for his late brother John, and District 9 (Allston/Brighton) challenger Pilar Ortiz noted that her song – “La Bikina” – was one of the last that she sang with her late grandmother.

The dances were sometimes personal, as well. Dis-

trict 5 Challenger Winston Pierre glided through an intricate formal step with his wife, while at-large incumbent Ruthzee Louijeune brought out the Boston Rhythm Riders – with whom she had worked out the line dance to “Boots On The Ground” – to show off what she had learned with synchronized, fan snapping resonance.

The spoken word – the performance art most familiar to politicians – leaned toward the campaign, as on Erin Murphy’s poem “I Show Up” and Henry Santana’s free verse (both are at-large incumbents). It also focused on social consciousness when At-Large Councilor Julia Mejia delivered a poem – featuring backing music and dancers – in which poverty meets change.

It also addressed life in general, as at-large challenger Alexandra Valdez compared motherhood to being able to negotiate the City Council (while bringing out a tote bag and then her two kids for assistance). She was preceded by District 3 incumbent John Fitzgerald, who started off the second set by firing off a few (very funny)

German Centre prepping for Vets Day

The German Centre in West Roxbury is hosting its 15th Veterans Day Celebration and Wall of Honor on Tuesday, Nov. 11, from 9:30 a.m. to 11:30 a.m.

The event is open to the public, and will feature speeches, music and an honorary 21-gun salute.

This year's guests include State Sen. Michael Rush, State Rep. William MacGregor, Boston AgeStrong Commissioner Emily Shea, Sgt. Major Michael Murphy, Boston City Council

President Ruthzee Louijeune, the Lord Mayor of West Roxbury Richie Gormley and the Honor Guard of VFW Post 2902.

Roxbury Latin will also be sending Rev. James Butler and music from the Roxbury Latonics, conducted by Minister Melvin Murphy.

The Wall of Honor is actually, four walls, as the program has grown since former German Centre Activity Director Carol Kelly started it 15 years ago. Kelly is retiring – the German Centre is holding a party for her on Oct. 24 in the building's auditorium from 1:30 p.m. to 3:30

p.m. if you'd like to stop by – but the program is still expected to grow, according to current Activity Director Daphne Guey.

"Carol has worked hard over the years for this wall," she said. "It shows the sacrifice and service of our veterans connected to the German Centre and even Carol has some of her family up there. It's generational and it honors those who served."

Guey said it's been amazing to see the walls grow every year and bring more and more veter-

was anything other than a show of the candidates' humanity," Paget said of the efforts that were made to make the show's concept and goal clear.

From there, things picked up. "It was fantastic," he said of how it had all developed. "It was a very creative process of people thinking of what it was they wanted to do and then evolving that thinking to bring even more dimension to what they were going to do for their performance."

District 5 incumbent Enrique Pepén – City Councilor for Hyde Park – closed the show (Mayor Michelle Wu had decided not to participate) by singing Billy Joel's "Piano Man" with Sean Hurley on the keys. The lyrics were changed to fit the neighborhood and his office ("Sing us a song, I'm your councilor...") and that, a few name drops, and his good-natured effort hit home.

The next day, Jay Paget – one of the show's organizers – spoke of the one-night production's background. It had previously been staged in 2005, 2007, and 2009 – with great participation and success – and was revived this year at the urging of some of the other original organizers.

Planning for it began about three months ago but, because none of the invitees were aware of the earlier stagings of "Spotlight on the Candidates," the response was slow and somewhat wary.

Consequently, there was much discussion with those who showed interest. Clips of earlier Spotlights (which featured Tom Menino, Ayanna Pressley and others) were also shared. "We wanted to dispel – quickly – that this

crowd eventually moved down the stairs and a few doors down the block to Antonio's Bacaro, where the good vibes that it had brought led proprietor Joe Garufi to make an impromptu and well-received speech of appreciation from behind the bar just before last call.

And shortly thereafter, the last of the theatre goers and candidates headed out – together – into the night, taking that evening's experience with them into the last days of this campaign season.

Placard arrests, Allston Christmas issues and Ringer lights

The Allston Civic Association (ACA) met recently and discussed crime in the neighborhood.

Or, more precisely, a lack thereof, when compared to previous years.

Boston Police Department (BPD) District D-14 Sgt. Edward McMahon stopped by for the monthly crime report. He said one major piece of good news is that Allston Christmas seemed a bit quieter than usual.

"There were only three house breaks in the last month, which is good because this is the first month everybody's back in school and usually it's the college kids who are getting broken into," he said. "With the few arrests officers have made in the last few months there were only

three-break ins, which is good because September is always a heavy month for that."

McMahon reviewed all the reported Part 1 Crimes in the neighborhood this past month including three aggravated assaults – two of which have led to arrests. He said there were also three commercial burglaries – mainly at storage facilities and one arrest was made, five car breaks, 20 larcenies (shoplifting and package thefts) and three auto thefts.

"One was a scooter and the other two I believe were cars that were left running, but the numbers look pretty good," he said. "Also, there was a peeping tom in the Allston Brighton area and there was an arrest made about a month ago too."

McMahon also discussed the recent arrests of two suspects allegedly implicated in the thefts

of 19 handicapped parking placards over the last couple of months. The BPD stated recently that they had arrested 55-year-old Andrea Doucette-Keating and 37-year-old Zachary Shelton, both of Brighton, as a result of its investigation. They had been stealing the placards to sell them.

"For good money too, hundreds of dollars," he said. "There were two arrests last year and two arrests this year, and so hopefully that will end that permanently."

The pair has been separately charged. Doucette-Keating has been charged with night time breaking-and-entering if a motor vehicle, malicious damage to a motor vehicle, larceny from a motor vehicle, and possession of burglarious tools.

Shelton has been charged with larceny less than \$250 from a person over 60, stealing a handicap placard, night time

felony breaking-and-entering-a-motor vehicle, possession of burglarious tools (window punch) and malicious destruction of a motor vehicle.

McMahon also discussed the issue of scooters, mopeds, electric bikes and similar and he said the city is starting to "crack down on" such conveyances by requiring they be registered.

"They're also supposed to be obeying the traffic laws just like every other vehicle, and so the captain is putting extra officers on down around the Harvard and Brighton Avenue area," he said. "That's where a lot of the scooters are picking up food in the evening. They'll be out just to make sure the scooters are registered and to spread the word that they're supposed to be obeying the traffic laws. The city is crack-

ing down on that because there have been a lot of accidents with pedestrians and people getting out of cars and getting hit by scooters."

Also at the meeting, during a discussion with the Office of Neighborhood Services representative Frank Mendoza, ACA member Bob Pessek asked about the Ringer Park basketball court lights.

"They're still on and our neighborhood has been asking that they get turned off as they used to be, and now (the neighborhood) is starting to feel like we're getting the runaround and some degree of disrespect," he said. "We're a little neighborhood and we have a petition signed by 20 people on our

ans and their families together.

"Over the past 15 years, we've added some photos and names," she said. "When it was first done, we got a lot of positive feedback. Staff, friends, family members, and participants from our Senior Day program, they would stop and read and then ask for their photos to be added as well. We now have four full walls."

Guey has been working alongside Kelly over the past few years, and said she's proud to take over an event that she's seen have

Guey said residents especially look forward to the day. "They look forward to it every year," she said. "We have many residents who have been here since the Wall of Honor started and they are very committed to the tradition. They get emotional when Richie and the Honor Guard start the salute."

Guey said the Wall helps build community, both at the German Centre and beyond.

"We'll have visitors come in and people will be like, 'Oh wow, I know this person!'" she said. "Even recently, we had an event that (District 6 City Councilor) Ben Weber was holding and he had someone come up to me and tell me about their family member on the wall. It's just really nice to see."

WHY HERE IN THIS NEIGHBORHOOD?

To the Editor:

My name is Lisa Fay, my husband and I live near the proposed homeless shelter at 5 Redlands Road, I love this neighborhood. It's quiet, close-knit and filled with people who care about each other. That's why the plan to turn 5 Redlands Road into a massive family shelter worries me so much. It's not that I don't want to help families, I do. But this wouldn't help anyone. The building was made for a few dozen elderly residents, not hundreds of people with young children. The developer says he's only done cosmetic changes, no construction. How could a building that was built in 1962 and abandoned for 3 years be suitable for families without any changes? It has small hospital rooms; there are no private bathrooms, only two showers shared by the whole floor and one kitchen in the basement for the entire building.

There are also safety concerns to the neighbors and residents and their visitors who might be suffering from drug addiction or mental disorders. I have great concern about many potential dangerous occurrences, but even more for the vulnerable children in the shelter and in the neighborhood. Also, the shelter will be a short walk to Holy Name Church School as well as other schools. It just doesn't seem like a place where any child could feel safe or cared for.

I've lived on this street with my husband for a long time; my parents bought the house in 1964. We're both in our seventies now and our health isn't good. He has serious heart and lung problems and I have back problems and I am a battling breast cancer, thus we rely on a handicapped parking space in front of our house to get in and out safely. Redlands is a tiny one-way street. It's already packed with

cars and traffic cutting-through from Centre Street. In the winter there are altercations where shoveled spaces are taken. There's nowhere for kids to play, and it's hard enough for emergency vehicles to get through now. Adding this many people will make things much more dangerous for everyone.

We're a caring community and we want to support families in need, but this plan isn't safe or fair for anyone involved. It's hard for me to understand why this particular location is being pushed so hard when it's so clearly unsuitable.

street."

According to Pessek the Parks Department said they wouldn't be turned on during the Ringer Park Renovation Project planning phase — <https://tinyurl.com/24cuz6bw> — but that hasn't happened.

"The biggest complaint we have is we live here and they blast light into our windows," Pessek said. "We've asked you, we've asked Parks, we've asked the electeds, and it seems very easy for you to turn them on, unannounced, so we're asking turn them off until something is solved."

Other residents reported residents using the parks for basketball. Mendoza asked that the petition be emailed to him, and added that several 311 requests

led to the lights being turned on for night basketball play.

"Parks felt that the volume warranted a response, given that the park lights are a public utility and they wanted to make them available to the public," he said. "They did acknowledge and spoke with you and Nancy directly Bob, and if there is any kind of way I can serve as a middle man between you and Parks to reach a compromise — I wasn't aware that there was a petition of 20 people."

Resident Kim Chow said she lives behind the basketball courts and the glare cannot be combated with curtains, and the noise from the court is also extremely disruptive.

Mendoza said he would follow up with Parks.

that is not responsive to current housing creation priorities," the LOI read.

The wood-frame building with an upstairs apartment was built circa 1895 by James Travers for his blacksmith shop, "Horseshoeing and Jobbers," after the huge Forest Hills viaduct realigned Washington Street.

In 1944, Joseph Vozzella, grandfather of the current Joseph Vozzella, of Roslindale bought the building and changed the occupancy to "manufacturers of cut stone articles."

Wellsmere – named after the Roslindale Street Vozzella Sr. lived on – is a large 36,000-square-foot property, 90 percent of which – states the Letter – is currently a parking lot [leased as satellite parking by the Faulkner Hospital].

The building adjacent, built in 2012, includes Commonwealth Bank and the Croft School (originally Harvest growers).

The Bulletin talked with Joseph Vozzella on a recent Friday.

"My grandfather before me started the business," Vozzella said. "He came here in the 20s and moved to the suburbs of Roslindale. He started carving stones in his basement on Wellsmere Road."

Vozzella recalled with pride Wellsmere's brush with fame in

2002 when Sean Penn and Clint Eastwood filmed a scene there for "Mystic River," penned by Dorchester native Dennis Lehane.

Vozzella, who was formerly deputy chief engineer for the Parks Dept., has his own business, Vozzella Design Group, at 3841 Washington St.

"I built some houses," he said. "This feels like the crowning achievement of my development. What I've done so far. No one is following me. It's just the right time."

Recently, Vozzella designed 147 Williams St., completed in 2024.

"I do largely civil engineering and land surveying and the monument business," Vozzella said.

"I've assembled a good team," Vozzella said, adding he will not be the architect. "RODE is the architect. I work with Eric Robinson."

At 62, "I'm trying to get out," he said. A lifelong Roslindale resident, he recently moved to the North End.

"It's a big lot, over 36,000 square feet. What would fit? We started with a big box, but it was too big. We carved everything out. Eric has covered everything articulation and shadow, brick comes down to the ground."

The submitted Letter is vague on whether they will be for sale, with 33 affordable, or

as rental at 36 affordable. Vozzella said the building, with 165 units, will be rental.

He expects to submit the large project review project notification form (PNF) in about three weeks. Meanwhile, he and his attorney George Morancy have been checking around with the neighbors, one of which is the MBTA.

"George talked with them yesterday," Vozzella said. "The south side of the property is a zone of influence of an access road 'Monument Alley' that abuts both Wellsmere and Davis Monuments."

Vozzella said he has been in contact with "Bob Wiggins at Gourmet Caterers, the new condo building across the street [3850 Washington St.], from the Davis and the Croft School." This apparently has paid off.

On Oct. 5, Chris Urchill and Cade Jerome, from 3850 Washington St., wrote a letter of support to the BPDA and copied it to District 6 City Councilor Weber:

"The highest and best use of this property today is residential development that can help address our housing crisis while taking advantage of the proximity to transit infrastructure... We urge you to approve this project and hope to see similar development throughout Forest Hills in the future."



said Cloutier. "There are a number of zoning and processor irregularities that occurred...shockingly, MOC/Burk submitted plans to ISD. They were amended plans submitted with a letter that said, 'hey, here are some amended plans. We're entitled to this permit by right, to change the occupancy to congregate living.' On Sept. 15, the permit was issued."

Cloutier filed an appeal on Marsh's behalf to void the permit and require a full zoning process. Cloutier said "congregate living" is undefined by law, but a "homeless shelter" is not approved for this location.

The MOC/EOHLC team gave their update. O'Brien said they have furniture and staffing in place and ready to move families into the shelter.

"We've worked out security...we've met all the permitting pieces, overall, the site is turn-key, ready to accept families." Newhall said all security measures are in place.

"This is a locked site, so here, no visitors allowed for families. They have only a key to their room...there are cameras all over the place...we're a congregate site. In our model, sex offenders cannot be placed in a congregate site."

Keogh gave those who live on Redlands Road and Manthorne preference in asking questions. Many remained unconvinced.

"We have all the documents. There are state laws that say what you can or cannot do. They say, 'we'll do our best.' ... These people are telling you lies," said Marsh.

Patrick Shearns, of 12 Manthorne, said that sex offenders are allowed by way of the MOC contract.

"Sex offenders are excluded from family shelters," said Newhall. "So, the contract is wrong?" asked Shearns.

"The contract is a scope of services," said O'Brien. Another Manthorne neighbor questioned how a building with 130 people has just 11 parking spaces. Burk said they met the threshold for parking.

Another neighbor asked, "Is there a possibility of two things: looking at your safety protocols, and enhancing them...and would you be open to a neighborhood safety council where we bring our concerns if we have any issues?"

"We're always open to tailor any of our sites," said O'Brien. Another neighbor said, "We have a caring, compassionate community. You're getting a lot of hostility. Who is pushing this through? Who has the final say?"

David Donnelly, 75 Manthorne Road, seemed to sum up what many at the meeting felt, "This is disingenuous; you're asking the group to believe you. You get your permit. All bets are off."

The meeting ended with more signing the appeal letter to the ZBA to request a full review of the project.

Housing Stabilization, Executive Office of Housing and Livable Communities (EOHLC) for the Commonwealth, the state's partner in establishing the shelter. The pair aimed to provide an update on progress of the shelter. Joining them was Alex Burk, one of the owners of the shelter building.

Abutters and neighbors who oppose the shelter have formed The Redlands Manthorne Willow Neighborhood Alliance and made available much of the documentation involving the site. They have hired Atty. Kevin M. Cloutier of the Cloutier Law Firm, LLC, to represent their interests in their opposition. Cloutier was also asked to give a presentation about the issues with the shelter.

The shelter has faced opposition from the beginning. The nursing home on the site closed in February 2022 and there were plans to build a 30-unit rental building on the site, but by January 2025 those plans were scrapped – presumably at least in part due to neighborhood opposition.

Rumors began to spread about a shelter at the site in the spring. When some details emerged that a shelter deal had been struck between EOHLC and MOC, public meetings were held on May 20 and June 26. New issues arose when Boston Inspectional Services Department (ISD) Planning and Zoning Division rejected two plans for the shelter sub-




