## ZBA approves Victory Programs over neighborhood opposition

Despite Mayor Wu's oft-stated goal of streamlining housing starts, she seems unable to streamline neighbors who can quickly band together to oppose it.

In the last four months alone, Jamaica Plain neighbors have banded together to oppose four housing developments, none of which are close to getting a building permit.

Chris Stamatatos wants to build a four-story, 12-unit apartment building at 561-579 Centre St. to replace a long-closed gas station. After six community meetings including two at the Jamaica Plain Zoning Committee (JPZC), JPZC denied the project five to three on May 7.

Memory care and supportive senior housing cannot compete with parking spaces as Rogerson Communities has discovered; its seven-story, 66 memory care rooms and 67 senior supportive housing apartments at its three-acre, 434 Jamaicaway campus is being fought by Lakeville-Beaufort Road neighbors, with some hinting at a lawsuit. The project seems to be on hold.

The project at 920 Centre St. is a proposed four-story, 85-unit condo building set around a courtyard behind the former St. Clare monastery which will be converted into 38 senior apartments. The developer, John Holland, is facing opposition from among others the venerable Arnold Arboretum which abuts the

property. Boston Planning Department community meetings have been canceled twice.

One size fits all over at Stonybrook: a plan to build a new, six-unit condo building at 19 Kenton Rd. to replace a circa 1858 farmhouse is being opposed by Stonybrook Neighborhood Association (SNA).

It is seeking succor from the Boston Landmarks Commission to designate the house a landmark; that way, SNA argues, the developer can convert it into three condos and a new three-unit house can be built on the lot.

That project is on hold awaiting BLC determination. But opposition can fail.

Victory Programs (VPI) wants to convert an existing use homeless shelter they've operated since 2021 at 81 South Huntington Ave. to supportive housing, which requires one simple zoning variance.

Despite loud opposition, VPI was granted that variance.

As reported by The Bulletin, the April 24 JPZC, after a long and rigorous hearing with 50 seemingly irate neighbors calling in opposition, the variance was approved seven to five.

That tight vote poked holes in Jamaica Plain's progressive veneer.

VPI's change of use variance was on the agenda of the May 6 ZBA in an unusual hour-long hearing during which 25 neighbors and one large South Huntington Avenue property owner called in to object.

The hearing was also unique in that zoning commit-

tee members, including the chair Sherry Dong, who normally rarely speak, had a lot of questions, all around safety.

Now called Visions of Victory, a pun on the previous use of the building called EnVision Hotel, the group's attorney, Joe Hanley, explained one recent change was that Dan Linsky, a former Boston police superintendent, had been hired as security consultant.

Hanley said that the former homeless shelter was allowed as a conditional use.

"We're changing now from one conditional use to another," he said, with a 41-room former hotel to be converted into 55 rooms.

Acknowledging the obvious, Hanley said, "There has been a lot of spirited discussion with a lot of folks in the neighborhood."

Another change, in addition to a professional security advisor on a short-term contract, was Victory has committed to "hosting our own continual community meetings," Hanley said adding that the Jamaica Plain Neighborhood Council (JPNZ) public service committee "was an ideal format."

Victory Programs CEO Sarah Porter said "we've recently hired Mr. Linsky for a short period of time. Many neighbors have complained that their quality of life is at stake, but this is not supported by [police report]

## WRCIA questions homeless shelter process

Over 30 people packed the West Roxbury Civic and Improvement Association (WRCIA) meeting on Tuesday, May 13 to ask questions about the proposed homeless shelter at 5 Redlands Rd. and to get clarification on any speed humps planned for West Roxbury. Information on the homeless shelter remained negligible as a community meeting hosted by the West Roxbury Neighborhood Council has been set for May 20 to address just this project.

As The Bulletin reported last week, The Massachusetts Executive Office of Housing and Livable Communities (EOHLC), in partnership with the Fitchburg-based non-profit, Making Opportunity Count (MOC) recently informed city and local officials that they would be leasing the existing space on Redlands Road for a shelter. State Rep. William MacGregor released a statement on behalf of himself, Sen. Michael Rush and City Councilor Ben Weber demanding a community meeting. Repeated attempts by the Bulletin to get

## WFH wants traffic safety Petition inspired by Lens Arthur Joseph

On Tuesday, May 13, the West Fairmount Hill Community Group (WFH) held – as part of its monthly meeting – a traffic safety discussion in response to the death of Lens Arthur Joseph.

On Monday, April 28, Joseph – a 5-year-old, having almost arrived home in the West Fairmount Hill area of Hyde Park – was struck and killed by the school bus he had just disembarked from.

In the weeks since, there have been questions regarding exactly what happened and how it could have happened, as well as the Boston Police Department's investigation of the accident.

Consequently, there were nearly as many elected officials, City and School representatives, police officers, and reporters present at the meeting as there were community members.

In that light, Boston Police Department (BPD) District E-18 (Hyde

Park) Captain Joe Boyle, prefaced the regular police report – and the discussion – by addressing the tragedy and the subsequent investigation.

“We know the family’s devastated. We know the community’s devastated. And I can say the officers that showed up on scene that day – I think they’re devastated with what they had to deal with,” Boyle began, before commenting on its unfolding aftermath. “And I get the frustration in the community for not getting the answers right now. But I can tell you there’s a thorough investigation, a comprehensive investigation ongoing right now, and it will continue. And when it’s completed, the facts will come out by the District Attorney’s office. Nothing’s being hidden.”

That noted, the discussion that followed – which was moderated by Deputy Director of the Mayor’s Office of Neighborhood Services (and former ONS Hyde Park Neighborhood Liaison) Cecily Graham, with assistance from Suffolk 14th State Rep. Rob Consalvo and District 5 City Councilor Enrique Pepén – was not contentious.

Instead, residents talked about their longstanding traffic safety concerns in the neighborhood.

Lens Arthur Joseph was killed on the lower stretch of a long, straight road (that changes its name three times: from Summit Street to Washington Street to Wakefield Avenue) descending at varying degrees from almost the peak of Fairmount Hill to Truman Parkway. Because of the tendency of cars to speed downhill, the many intersecting side streets, the area’s high residential density, the number of parked cars, and the school and playground that are near the bottom of it, that road has long been the source of instinctive wariness for both residents and local drivers.

In relation to that, and in response to Joseph’s death, WFH founder Marcia Kimm-Jackson read her group’s petition to the City of Boston regarding traffic calming and school safety measures.

The petition makes four requests: the installation of speed humps along the Washington/Wakefield corridor, and on affected side streets; school bus monitors on Boston Public Schools buses; the reinforcement of the crossing guard program; and the attendance to all measures recommended by the Boston Police Department at the conclusion of its investigation.

In response, Pepén said that there is a shortage of crossing guards (the hiring and training of whom are overseen by the BPD) with 51 current openings, and Consalvo added that the Department of Conservation & Recreation also has available crossing guard positions.

Kimm-Jackson also read an email sent to the WFH last November by Nathaniel Thomas – one of the first to come to Joseph’s aid after he was struck down. Addressing the ineligibility of Washington Street for the City’s Slow Streets program (and speed humps) because of the MBTA bus route that it is part of, he also expressed concern regarding the lack of speed control for the half-mile stretch between intersecting Garfield Avenue and Truman. “So I just want you to know that this is not a new issue,” Kimm-Jackson made clear. “We’ve been requesting this.”

Graham responded to what Thomas had written, saying that – while Washington Street isn’t ineligible for Slow Streets – it would require a more involved community process to establish it there because of the MBTA bus route, school buses, and the new street parking plan that it would

entail. “Talking about speed humps on that street would change the make-up of that street, so we would have to have a more in-depth conversation with the direct abutters there,” she explained.

Generally related to that, prior to the traffic safety discussion, Pepén had announced \$2 million in City funds for safety improvements the length of Wood Avenue, on the Hyde Park-Mattapan line. Allocated last year, it came about as a result of the death of Ivan Pierre – a 4-year-old killed in a hit-and-run on that street in July of 2023. Almost exactly one year before that, a system of chicanes (a de facto road slalom) had been installed as a traffic calming measure in response to the neighborhood’s request for speed humps. It was received with much local consternation.

There were only a handful of comments from the dozen or so community participants, but some of them focused on local school bus/traffic/parking problems. One neighborhood resident described how – two weeks earlier – she’d had to direct a bus onto the sidewalk in order for it to turn around because of improperly parked cars on both sides of the street making it impossible to continue. Another resident – Robert DeVeer Jr. – spoke of a school bus that drives up his street. “Every day at 4 o’clock, he blows the stop sign at Loring and Garfield. Every single day. With kids on board,” he said. “The speed varies. Sometimes he goes fast. Sometimes he goes slow.”

# Wu addresses West Roxbury concerns

On May 14 at the Corrib Pub, Mayor Michelle Wu spoke to a room full of concerned citizens eager to ask their mayor questions, during the monthly West Roxbury Business and Professional Association (WRBPA) meeting.

The mayor gave a 15-minute talk on the choices she has made from housing to safety in Downtown Crossing, emphasizing how she wants Boston to be a home for everyone, before opening up to questions. Some would not stop addressing the mayor on areas of concern so the president of the WRBPA, Jim Hennigan, told people to respect the mayor's time as she had a press conference to attend afterwards.

A frequent concern is a senior center for West Roxbury. One member half-joked that she does not think a senior center will be built during her lifetime or even Mayor Wu's and she is grateful for the West Roxbury Elks which offers seniors activities three days a week.

"We are not going to go play in Billings Field. We need something," she said.

Wu said she understands this and has had countless conversations with State Rep. Bill MacGregor and Councilor Ben Weber and has talked to a few developers which did not work out. "The truth is there's nothing in the works yet in terms of a location," Wu said. But she did point out that the City of Boston funds the Elks, allowing for the three days per week seniors enjoy.

"What are you doing about making housing for families more affordable?" asked one resident from the back of the room. He gestured with his hands that she was building houses like this, indicating vertically, and she was not building horizontally. Additionally, he asked what she was doing about the zoning laws for single families as well as making the MBTA more safe and afford-

able.

Wu said some of what he is seeing on the housing front is the city's attempt to create more options for new buyers as well as seniors looking to downsize. "Part of the answer is we have to create more housing of all types," she said.

One thing Wu said the city is doing for families is to try to make it easier to buy multi-family homes by creating a co-purchasing program. Families can pool their resources and the city will cover 5 percent of the down payment, with no interest loans, as well as connect them to attorneys to help them underwrite it so everyone's name is on the deed. Accessory Dwelling Units (ADUs) are another example of ways the city is helping. "Granny flat" or "in-law units" are some nicknames for this, Wu said. The city is working with zoning to make the process expedient and is working this plan in three phases, starting with areas with the largest lot sizes. Doing this in dense areas is more complicated as it poses issues to neighbors. She said the goal was to create multi-generational family dwellings.

Regarding the MBTA, Wu emphasized the progress of no more slow zones compared to a year ago. Wu said that, according to MBTA Director Phillip Eng, the collective 130-ish days of shutdowns saved the city 40 years in the long run. She said currently the tracks are in good shape, but the signal system needs work. Wu also said it is unfair that commuter rail prices in West Roxbury and Roslindale are about three times as much as in other parts of Boston.

"It is not right," Wu argued if they brought fares down that would increase ridership.

The issue of the Centre Street Road Diet has been divisive among West Roxbury residents, and one resident thanked Wu for the bike lanes and finally feeling safe. The concern was now for Washington Street. Wu likened this issue to rearranging furniture in one's liv-

ing room. Every member wants to use the room for a particular use. Wu said her husband just wants to watch sports and be left alone, while she wants to kick up her feet and her kids want to play.

Her point being that the city needs to create a safe space that takes everyone's needs into account. While slowing down busy streets is good for safety it then creates hazards in residential areas where due to driv-

ing apps, people use the quiet streets as cut-throughs and parents complain to Wu that they cannot allow their children to play in the front yard for fear of being run down by a car. And then speed bumps cause aggravation to drivers who simply want to drive through the area to their destination, while the residential area dwellers are happy for the slow traffic.

Commercial corridors have their stresses in terms of deliv-

ery drivers as well as handicap safety concerns.

"We have to be in the right balance and that takes feedback over time."

The data shows that drivers are driving at the speed limit now, versus many traveling 20 miles over the limit, which is what happened before the diet on Centre Street. Wu acknowledged the strain on small businesses and said the city has made tweaks to fix things.

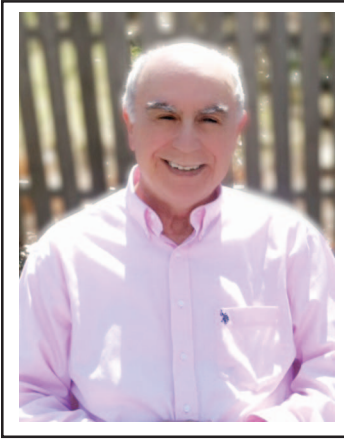

# Vehicle removal is SLOW

My sympathies to you if you’ve ever dealt with the city for the removal of an abandoned vehicle near your home or workplace. It seems not to help if that vehicle has license plates or not: so many days have to elapse before the police put a green sticker on it, then comes the interminable wait for the Boston Transportation Department to tow it to a storage lot. The abandoned vehicle could be out in front of your home for weeks, if not for months, before it is removed. Wherever it is towed, another wait sets in before finality occurs, some of which wait times might be dictated by statutes.

The city needs to expedite its handling of abandoned vehicles—whether car, truck, camper, or trailer. The slowdown, I’m told, results from Transportation Department’s inability to tow the vehicle within an adequate time interval. Sometimes this is caused by the need to have a larger tow truck remove trucks/campers/ trailers; at other times, the delay is caused by the lack of storage space at the tow lot, as more and more people abandon their vehicles at the high price of repairs, insurance, excise tax, and in-

spection (\$35) charges. Once abandoned vehicles are removed, spaces are freed up for workers and homeowners to park. This is especially important in highly populated areas where on-street parking or at a nearby public parking lot is at a premium. If you live near a community that prohibits overnight parking—that’s you, Brookline—then their residents occasionally love to park for weeks at a time on city streets when the owners spend a couple of weeks on vacation. So the vehicle is not officially abandoned, but . . .

information from both the EOHLC and MOC about the shelter were unsuccessful.

The type of shelter, how many people, security measures, length of occupancy, traffic control, etc. remain unknown. In attendance at the meeting were Mark Cohen from Councilor Weber’s office, Ben Tayag, the West Roxbury Liaison for the Office of Neighborhood Services and Rep. MacGregor. They responded to questions and comments based on their limited knowledge. Cohen said that Councilor Weber was kept in the dark about the project.

“At this point I would say . . . we have to see the roll out, we’ve not seen numbers, programs. We don’t know anything.” He said the lack of community process was of concern. “It is disappointing as a start point for us. We need to have the information.”

He said that by the time they got the call informing them, it was a done deal. “That’s why we were shocked. It’s very important that people show up to hear what the state has to say. The state has a vendor who will provide the services.”

Tayag was able to check the current permits for the building which showed there are no variances required so the work on the building, like painting and fencing, is allowed.

Rep. MacGregor reiterated being surprised and had no new details about the shelter. “In Bos-

ton, you have to do a community meeting for everything...we wanted them to do a community meeting, especially before they signed a lease. After reaching out to them several times we got a call back and they said, hey, we signed the lease. We said, we want this community meeting done.” MacGregor said he hoped all the questions would be answered on May 20. “I have as many questions as you guys have.”

In response, someone asked, “Why can’t ISD (Inspectional Services Department) just pull the permit and stop the work?”

“I don’t believe they need permits for an emergency shelter,” said MacGregor.

“I am dismayed at the lack of transparency,” said Judy Halper. “If the lease is signed and it’s a done deal, how much say does the community have then?” asked Tara, another attendee.

“That’s an excellent question,” said Cohen.

“The real process comes next week,” said Martin Keogh, WRCIA acting president.

“I would like to know how something like this happens, and nobody knows anything?” asked another resident. “Basically, this is a fait accompli. This is ridiculous. Nobody knows anything? Sorry, I think this is not true,” she added.

Keogh said, “I think they honestly got caught off-guard.”

Some in attendance appeared

to support the concept of a shelter. “I believe that fence that went up is a very beautiful fence,” said Patricia Connors. “I think it’s a wonderful service.”

The general consensus remained that the community had been totally ignored by the EOHLC.

“Everybody got hit over the head with this,” said Terri Halliday, WRCIA board member.

Plans for the installation of speed humps was the other big agenda item.

“Just so you know, the city does not plan to install speed humps on every street that is eligible,” said Tayag. He said that speed humps will only be installed on streets where the majority of residents are requesting them. “A street hump is not going to magically appear on your street.”

Tayag assured the group that neighbors will have a long time to hear about and discuss the installation of speed humps on their street. Right now, only Maxfield Street and Northdale Road have enough resident support for speed humps to move forward. Tayag said residents will decide. “It is based on neighbor interest,” he said.

The new leadership for WRCIA was also voted on and approved. The new officers are Daniel Durant, president, Martin Keogh, vice-president, and Terri Halliday, treasurer.

data.”

ZBA member Katie Whewell said that when the homeless shelter first opened in 2021, “a police car was parked out in front but the neighbors complained, they wanted the car removed because they felt it stigmatized the neighborhood.

“Complaints are heard but they can’t be documented,” she said but encouraged Victory Programs “to do more with the neighbors.”

Dong wanted to move to public testimony. “We’ve had a lot of emails,” she said. “We want to give them a chance.”

Connor Newman of the Boston Office of Neighbor-

hood Services was first. “The mayor’s office wants to go on record in support because of the critical services [Victory Programs] provide,” he said, adding there were 50 letters in opposition and two in support.

State Rep. Samantha Montano and City Councilor Ben Weber both spoke in support and asked for the board’s approval.

The city of Boston contributed \$9.9 million to Victory Programs at 81 South Huntington in Jan. 2025.

Nora Lutz of the neighborhood housing development office came on the call and requested that “this should move forward as permanent

housing.”

It was all down hill from there as the chat box lit up with 56 messages.

Only one caller testified in support.

Attorney Bernard Shadrawy said he represented the owner of 46-80 South Huntington Ave. “that he purchased in 1968, 107 rental units, 200 people live there.

“My client has provided two emails. [He] is not interested in stopping this project. I only ask that the city conform to the 6.3 zoning,” he said. “This violates the conditional use. You cannot substitute one non-conforming use with another,” Shadrawy

said. “Unless my client’s proposed conditions are agreed to this should be denied.”

Shadrawy did not provide those conditions in the chat.

Hanley replied that Porter had met with “the Moscrow family [the owners of 46-80 So Huntington] across the street and had an extensive meeting last week.”

“Some of the demands were not applicable,” Hanley said.

Caller after caller came on with allegations of needles on stoops, drug dealing, car break-ins and “utter disregard for the residents” on South Huntington and the Jamaicaaway.

Cynthia Lewis of 50 Jamaicaaway was blunt; ”shame on the mayor. Shame

on Victory Programs. This is not how you treat neighbors.”

Linsky repeatedly said that residents should call 911 with complaints so that there is a record.

One caller from 40 Jamaicaaway dismissed this.

“Who wants to call the cops?” he said. “The people have already caused the problems”.

ZBA member Giovanni Valencia made a motion to approve with one proviso. “I would like to see increased outreach with the neighbors,” he said. “This is a very important program. I make a motion to approve.”

A vote was taken and the variance was approved seven to one.

ZBA member Alan Langham, who represents labor unions, voted no. Apparently the opposition changed his mind; earlier he had said, “This sounds like a pretty nice project.”

Architects never give public opinions on their clients but Gail Sullivan is different. Sullivan lives in Jamaica Plain at Forest Hills and her StudioG, with a history of designing social housing, is commissioned to do the conversion with Gabrielle Shelbourne as lead architect.

Sullivan went on LinkedIn later on May 6. ”So happy VPI was approved by the ZBA today to continue doing the life-saving work they do.”
