Housing, Food Pantry top HPNA Confusion on Central Avenue

On Oct. 2, the Hyde Park Neighborhood Association (HPNA) held its regular monthly meeting for the first time since July. Its first two appointments concerned proposals for new residential construction in keeping with the citywide trend to expand housing beyond existing zoning limits.

The first – for 704 Metropolitan Ave. – requires zoning relief for what would be a standard design six-family (the 2-bedroom units of which will be marketed as condominiums) that the owner is proposing for a vacant lot that is currently zoned for two-fam-

ily construction.

Even though one-to-one off-street parking is proposed for each of the six units, the main concern – which was raised by abutters in attendance – addressed the fact that the proposal does not meet the two-to-one ratio spelled out in the existing Hyde Park zoning code.

In response, project attorney Ryan Spitz got at the reality of zoning regulations as they relate to City Hall's implementation of policies that are often at odds with them.

"Even if I went with compliant parking... most likely you're going to see they're [the Zoning Board of Appeal] going to reduce parking to provide more open

space or more permeable space," he explained. "Even at six [spaces], I wouldn't be surprised if they try to cut it down even more."

The ZBA hearing date for this project application is Tuesday, Nov. 18. For hearing information, visit www.boston.gov/departments/inspectional-services/zoning-board-appeal.

The other new construction appointment concerned the proposal for 26 Easton Ave. that would tear down and replace a two-family with a four-story eight-unit building with eight parking spots.

The units would be offered as

Jackson Greenway: The success of partnerships

The Jackson Greenway ribbon cutting on Sept. 17 was more than just celebrating a 681-foot-long, 80-foot-wide walkway from Amory Terrace to Centre Street; it celebrated a new community that didn't exist 15 years ago.

What Rebecca Mautner, director of real estate for the Jamaica Plain Neighborhood Development Corporation (JPND), the entity that built the \$2.7 million walk, called the biggest development site in the city, the walkway plan belies its significance: it connects seven, income-restricted social housing apartments over 11 acres.

Terronda Ellis, CEO of JPND, let the neighbors talk about it when she introduced Purple Reign, who lives at 75 Amory Ave. which opened in 2017.

"Let Purple tell you what it's about," Ellis said.

"Welcome everybody to my front yard," Reign said, "When I first moved here this was just dirt. Now, look right here in the hood, are you kidding me?"

"I'm a thick chick. Now I can walk on this cut-through to the station. I don't have to walk around Amory Street."

Shiela Dillon, chief of housing, has seen all the transformation during her 25-plus years in the city's housing office.

"This is a community benefit that the community wanted, surrounded by 700 units of new housing," she said. "I'll leave you with this thought: people can make green investments that can lead to gentrification. But all of you said that's not going to happen here. This is improvement without gentrification," Dillon said. "Boston needs a place like this."

Jeffrey Sanchez was the state representative during most of the planning and early construction of the 11 acres, and said, "Mossik started this," referring to Mossik Hacobian, who was the CEO of Urban Edge from 1982 until 2011.

"When we first started out, Mossik brought it up all the time to Mayor Menino.

"A lot of people said 'no

Neighborhood zoning on the docket

The Boston Planning Department announced recently the scheduling of Neighborhood Housing zoning discussions in Hyde Park, Roslindale, and West Roxbury respectively.

The first meeting is set for Roslindale on Oct. 15 at 6 p.m. at the Boston Centers for Youth and Family (BCYF) Roslindale Community Center, the second is Oct. 22 at the Hyde Park Community Center (the Muni) at 6 p.m. and the West Roxbury meeting is set for Nov. 5 at 6 p.m. at the BCYF Roche Community Center.

The Planning Department stated that the reasons for these

way’ but Menino said just keep talking,” Sanchez said. “Out of it came JPNDC, Urban Edge, The Hyde Square Task Force, that crowd, you’ll get what you want. We came really close.” Sanchez also referred to the early Egleston Square Neighborhood Association (ESNA) as a neighborhood group involved in Jackson Square.

Left unsaid was that ESNA was among those who said ‘no way’ to Urban Edge when it proposed in 2001 to be the first to build on the 11 acres at 10 Amory Terrace, now within a few yards of the new greenway.

But after a protracted struggle with ESNA opposition and the Jamaica Plain Neighborhood Council, the 64-unit, six-story, income-restricted housing was opened in 2005, replacing a tow lot and carwash.

As Emilio Dorcelly, the current CEO of Urban Edge, said at an earlier Jackson Square groundbreaking, “Mossik saw things that did not exist.”

Charles Hills, co chair of the JPNDC board and one of its original board members put more context relative to the greenway ribbon cutting. “Forty-five years ago people thought this was just a backyard, a place for tow lots and junk yards,” he said. “But you locked it in. The energy here kind of overwhelms me.

“Mossik was like John the Baptist. Go straight down the road. Mossik had this slide carousel, if you gave him a minute he would go through it. His en-

thusiasm and his vision, as primitive as it was, showed us,” Hills said. “Before you knew it opportunity came, three groups, JPNDC, Urban Edge and The Hyde Square Task Force. Friendly competition, ‘Pick me! Pick me!’

“Everybody put their heads together; they all came together. Jackson Square Partners. This is the end result. I’m happy to witness that.”

Hills failed to include the other partner, The Community Builders (TCB), which has now become Centre Street Partners with Mildred Hailey Apartments.

Jackson Square Partners began with 225 Centre St., opposite Amory Street which opened in 2013, the first collaboration between TCB, Urban Edge and JPNDC.

The landscape architect for the Jackson Greenway was Deborah Meyers, who also landscaped 250 Centre St. at the head of the walkway. Among other challenges, Meyers had to negotiate a 36-inch below-ground electrical duct which powered the adjacent Orange Line and commuter rail.

A complicated web of funding sources was glued together to make up the \$2.7 million budget, including \$365,000 in equity from TCB and the Jackson Square Partners.

Another source was the Community Preservation Act (CPA), directed by the Boston Community Preservation Committee (CPC) and its di-

rector Thadine Brown, who followed Hills saying the CPA was “following the energy.”

“The CPA gave the greenway \$750K,” she said, “It has a meaningful impact.”

The greenway ends in a jungle of trees, overgrowth and rubble, but beyond that is rising 127 Amory St., a six-story, 96-unit, income-restricted

apartment house by TTCB.

When completed, an extension of the greenway from Amory Terrace to Atherton Street will be built, owned and managed by TCB; the estimated cost is \$1 million,

Council to look at veterans programs amid fed shutdown

District 2 City Councilor Edward Flynn called for a hearing last week during the regular session of the Boston City Council meeting to discuss impacts on veterans programming for currently serving U.S. military and military families during the current federal shutdown.

At the time of publication,

no deal had been reached relative to the shutdown. According to The Military Times – www.militarytimes.com – there are several issues facing military families. According to the VA itself, career transition programming, career counseling, GI Bill assistance services, cemetery applicant assistance, benefits regional offices, unfunded outreach to veterans, VetResources emails, responses to press inquiries,

placement of headstones at VA cemeteries and regional outreach services have all been suspended.

Family centers, support services and spousal benefits – <https://tinyurl.com/bdzaezv> – and – <https://tinyurl.com/ehkhdwbj> – respectively for currently serving troops, are all facing sporadic closures during the shutdown. Local food pan-

Never again in my lifetime

Consider the following three questions: Will Boston ever be accorded home rule by the state legislature (a carryover from the Know-Nothing days when the Protestant suburbs wanted to control Catholic immigrant Boston)? Will municipalities or the state ever give tuition reimbursement to parents sending their kids to private/parochial schools (each parent that does so in Boston saves BPS \$33,000 annually)? Will utility companies ever be able to open up any Massachusetts street—no matter how little trafficked—without calling for an expensive police detail (it’s a state law)? An affirmative answer to any three of these questions occurring in my lifetime is “probably not”—very probably not. But there is one question to which the answer is definitely, absitively-positively not: will there ever be in my lifetime a date like last month’s sixteenth day.

September 16, 2025, was a most unusual day. There are a dozen or more days in a year that are “math” days, meaning if you look at the date and do certain math operations, all the numbers will be accounted for, except the “20” in 2025. For example, May 5 of this year (5/5/25) was a math day by virtue of multiplication. Similarly, June 19 (6/19/25) was a math day: 6 + 19 = 25. But a math day such as the one first mentioned in the opening sentence of this paragraph will never occur again in my (and probably your) lifetime.

Why? Let’s look at it: 9/16/25. It’s not so much that 25 is the sum of the addends (9

+ 16). The unusual quality is based on the Pythagorean Theorem, which is used to solve for the hypotenuse of a right triangle, or conversely, for one of the non-hypotenuse sides (legs). Thus $a^2 + b^2 = c^2$. Thus 3 squared (9) plus 4 squared (16) = five squared (25).

Following this line of thinking, June 8 of 2010 (6/8/10) and August 6 of the same year (8/6/10) were Pythagorean days without the first two numbers being elevated to the second power, as were May 12 of 2013 (5/12/13), December 5 of 2013 (12/5/13), and August 15, 2017 (8/15/17). [October 6 of 2008 (10/6/08) and October 8, 2006 (10/8/06) could be considered Pythagorean—also without the elevation to the second power—with the hypotenuse, 10, coming first.] September 16 of this year: maybe it was a good day for picking apples or for a high school athletic team, but an absolutely magnificent date for Pythagorean theorem fans. Enjoy it because such of its ilk will not come again soon.

HOW CAN WE NOT SUPPORT A STATE AUDIT?

To the Editor:
We need every government department, agency, commission and office holder to be audited now. Here are just some of the recent reports of government corruption:
-Disgraced Suffolk County Sheriff Tompkins spending \$115,000 last year with a State Procurement (P) credit card.
-Attorney General Andrea Campbell used the same P credit card last year to supposedly learn about jurisprudence in Paris, the Virgin Islands and other exotic destinations to the tune of \$288,000. (No wonder she won’t take legal action to support the People’s Audit.)
-Governor Healey using the “P” credit card to travel to Florida, D.C., N. Carolina, Ireland, Puerto Rico, New Hampshire and the Vatican. These were very expensive trips. We paid for them. Is it unreasonable to examine the expenses incurred?
-Flagrant spending by many State departments at casinos with these infamous P cards.

tries in and around military bases are also seeing huge upticks, as large as 34 percent, in military families using services during the shutdown – <https://tinyurl.com/4jz8snn4>
Flynn said he’s been hearing from veterans and veteran families about concerns regarding the shutdown, and wants to bring in veterans, Boston Commissioner of Veterans Affairs Robert Santiago and State Secretary of the Office of Veterans Services Jon Santiago to testify on how services are being affected and how the city might be able to fill some gaps.
“It is uncertain at this time which veterans benefits will be impacted by a government shutdown,” Flynn said. “However, pay for military members could be halted, and agencies such as the Department of Housing and Urban Development (HUD) and the Department of Labor, that have exceptional partnerships with the VA could be halted, potentially delaying

needed benefits for our veterans and military families. For example, the New England Center for Veterans up here on Court Street receives federal funding from HUD and the Department of Labor for their job training programs.”
Flynn said many are already reaching out to him to see how the city could supplement their needed benefits and services if the shutdown suspends them.
“Many veterans, military members and families have expressed concern to me that some of their benefits and pay would be delayed during a government shutdown, and this extends to women veterans, homeless veterans and veterans with disabilities,” he said. “And as we know, the fastest growing group of homeless veterans in the country are women.”
At-Large City Councilor Julia Mejia said there will likely be more of this kind of need in the years to come.
“Given what’s happening on

the national landscape this gives us an opportunity to utilize our bully pulpit to give voice to those who are going to be impacted,” she said. “This is just the beginning of it.”
At-Large City Councilor Erin Murphy echoed Flynn’s concerns, and said while Massachusetts has the most amount of funding per capita for veterans, it’s necessary to do more in this situation.
“Those taking advantage of what they deserve are understandably nervous, and it’s our job to make sure the city is on top of this, making sure that nothing is interrupted,” she said. Murphy went on to say her 91-year-old stepfather is receiving hospice care at the VA right now and she is concerned about his care.
“I know directly that these services are essential, and if there is any chance that these services will be interrupted we need to make sure we’re supporting our veterans,” she said.

Potential parking issues at Cambridge St. parking-less hotel

The proposed hotel at 393 Cambridge St. in Allston is going through the Boston Planning Department Article 80 Large Project Review Process so that City Realty can build a 96-room facility on the site with no off-street parking spaces.

The logic, according to City Realty representatives Jacob Simmons and Attorney George Morancy, is that this hotel will be a draw for those tourists looking to rely on public transit, ride share, bike share or walking and not having to rent a car. Boston has often been cited as being confusing to drivers unfamiliar with the roads.

As the legend goes, the streets were formerly paths designed by cattle.

The process in recent weeks included a meeting held by the Boston Planning Department and was also discussed at the Allston Civic Association (ACA). Morancy and Simmons presented the idea as a way to pro-

mote more environmentally-friendly means of transportation for tourists, cutting down on vehicle emissions by not having an inexperienced driver get stuck in traffic, take a wrong turn or circle around looking for street parking that may or may not exist.

“The development is committed to responsible development that addresses climate change and this hotel will include energy efficient systems, sustainable building materials and stormwater features that will protect the environment,” he said. “And this fits perfectly with the city’s goal of sustainable transportation and will reduce vehicle traffic. This is intended as a hotel destination for people who aren’t looking to be tied to renting a car in Boston.”

The proposal is for the building to basically be encased by the neighboring building – the seven-story residential site at 8-12 Wilton St., which is part of the Phase 2 mixed-use development City Realty is undertaking in the neighborhood known as Allston Square – <https://tinyurl.com/bdhn26up>

The hotel will have 96 units, a covered valet area (staging before the cars are brought to an off-site parking area), street trees and other minor landscaping. Simmons said they will partner with a hotel company to manage the site once it’s built. Simmons said that they have not solidified a community benefits package yet, but said they will have one together for subsequent meetings.

“I know that typically there are fees associated with commercial development that are used for community benefits through the Planning Department,” Simmons

said. “We expect to have additional contributions... And I think that because this is such a limited service hotel, we do think there is an opportunity to work with the local main streets groups.”

Residents were wary of the parking lot-less proposal, as the area already has severe traffic issues.

“I’ve been an Allston resident for over 60 years, and I see this edifice as a complete, total, traffic nightmare,” said one resident going by Jeanne. “That area is already very heavily traversed, between the schools, the hospital and more in the area, and I don’t see how this isn’t going to make that traffic worse. And why not consider putting this on Soldiers Field Road, a much better area to accommodate the level of traffic that this is going to produce.”

Morancy said there will be deliveries and drop-offs, with dedicated areas for both on Wilton Street behind the building.

“I understand your comments and concerns and I’m not diminishing or belittling them, but we’re pretty confident that in terms of the work we’ve done with the city and the Boston Transportation Department’s experience with hotels all over the city, that traffic concerns arising from this type of use at this location will not be severe,” he said.

ACA President Tony D’Isidoro said even if there are no vehicle trips generated by the hotel, construction congestion could be a serious issue.

“There are a number of other development projects taking

place, and I always make this assumption and I hope it’s the case, but if a number of these abutting projects go into the ground at the same time, I hope there is some coordination between the proponents or working with the city, because we’re talking about a very strategic intersection,” he said. “If two or three of these projects are going on at the same time it could really cause a mess.”

Simmons said he’s already reached out to representatives of the Great Scott redevelopment – <https://tinyurl.com/3szv66ws> –

and will coordinate with developers and the city.

Resident Sara Iwany pointed out that the certified hotel might help reduce another problem cropping up in Allston and Brighton.

“It might help to reduce the illegal Airbnb’s that are still going on, if there’s an alternative to that” she said. “Especially in this neighborhood which would in turn alleviate the rental crisis as you can’t use those for illegal profit.”

condominiums, likely starting at around \$500,000. This led to discussion regarding lower income home seekers being priced out of the market until the proponent – Ricardo Jean – eventually stated that he would be offering four of the eight units for sale, while renting out the other four at below market to low-income (Section 8) levels.

The HPNA did not vote on either of the proposals.

The evening’s third appointment brought attention to the Hyde Park Emergency Food Pantry, which is in the Municipal Building/BCYF (1179 River St.) and is open for business on Tuesdays and Thursdays – as well as the second Saturday of the month – from 9 a.m.-12 p.m.

Manager Margaret Dietzel stated that – as of the end of September – the Food Pantry was providing groceries to more than 400 Hyde Park households in need, adding that there has been a steady increase of 40-50 additional families per month since

February. “These numbers reflect just how many of our neighbors are struggling with food insecurity, and how essential the Food Pantry has become,” Dietzel said of its under-the-radar importance to the community.

The Food Pantry is looking for 1-2 volunteers able to comfortably lift 25 pounds and stand through a three-hour shift. It is also taking monetary and non-perishable food donations.

In Hyde Park traffic news: Mayor’s Office of Neighborhood Services (ONS) Hyde Park Liaison Zoë Petty gave an update on the directional reconfiguration revolving around the traffic island at the convergence of Central Avenue, Webster Street, and Everett Street.

The process has been somewhat disjointed:

Two-way traffic had been allowed on both sides of the island

The Bulletin prior to the Transportation Department’s decision to make each side of it one-way as a calming measure.

Last Wednesday, a (virtual) Central Avenue community safety improvements meeting had been held. However, due to a City Hall miscommunication, Central Avenue had already been restriped to reflect the new traffic pattern well before that, and – just as significantly, from the confusion standpoint – well before the necessary Do Not Enter and One-Way signs could be posted.

Since last week, the signs have been installed, and drivers are regularly missing them.

On Thursday, it was also brought up that worshippers at the Hyde Park Seventh-day Adventist Church are now using the new, yellow striped, broadly spaced traffic-flow lines as parking spots.

At the conclusion of the update, a request was made for someone from the Transportation Department to come to an upcoming HPNA meeting to explain everything in more detail.
